Passengers transport services of private bus sector in the Eastern Province were controlled by district secretaries of Ampara, Batticaloa and Trincomalee before the year 2009.

Subsequently, Eastern Province Road Passengers Transport Authority Statute No.2 of 2009, approved by the Provincial Council session on 21.07.2009 and all power including administration and operation affairs of the private bus service in the Eastern Province has been taken over by the Eastern Province Road Passenger Transport Authority.

Objective of this Authority is reach to the target of provide better transport service in the Eastern Province in order to uplift the living standard of public though the activities of cultural, social and economic field.

Key function in this regard are :-

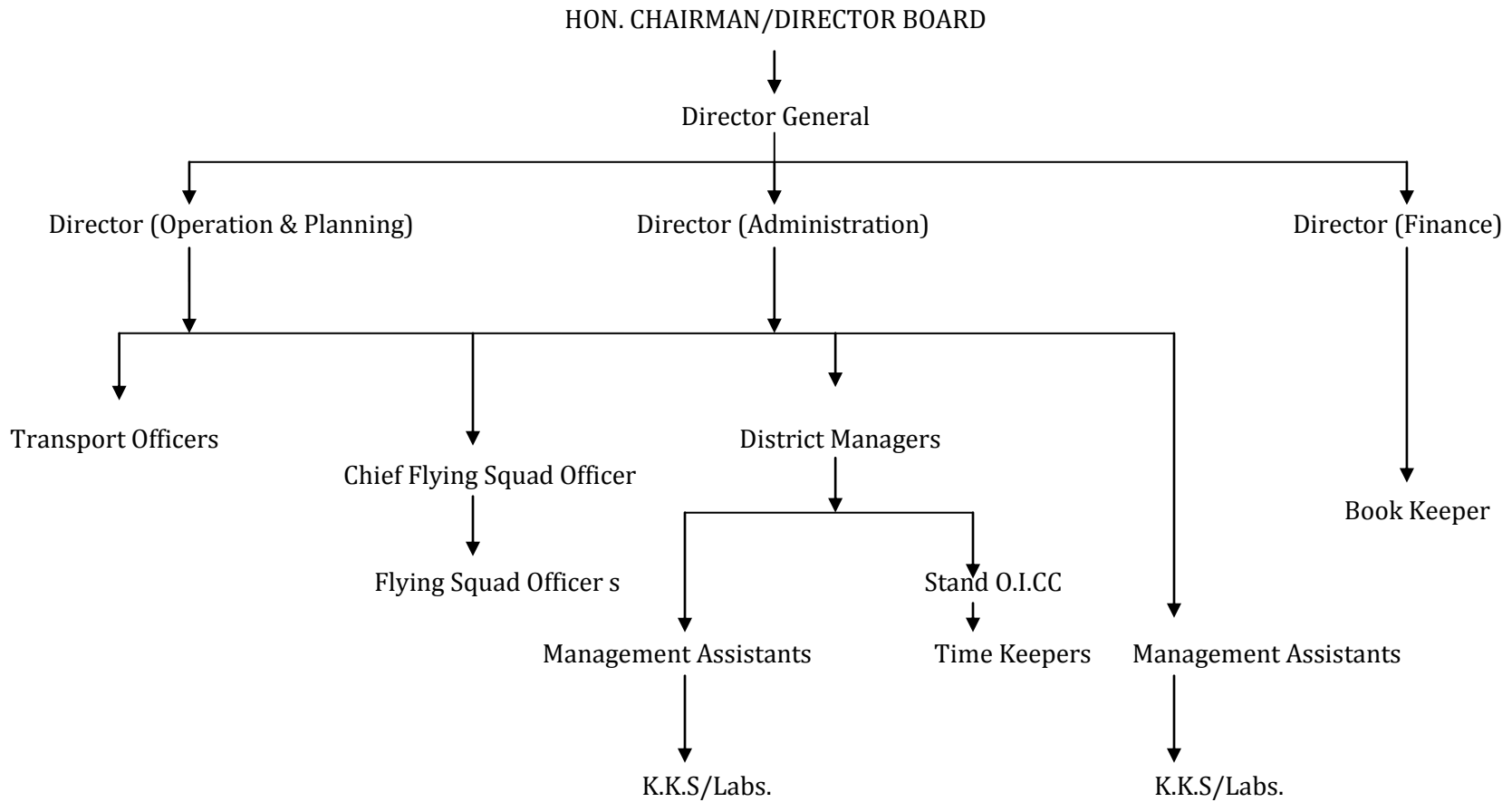
- Provision of necessary infrastructures for transport service.
- To develop good quality transport service for public and for transport goods and administrative it equally throughout the province.
- To bring about safe comfortable and timely transport service for public.

Main power of this Authority is entrusted to the Hon. Chairman and Director Board. The Director General is the head of the transport authority of this province.

Organization Structure:

Under the Director General of the Road Passenger Transport Authority, there are three Directors in the head office in charge for the administration, operation cum planning and finance. In addition to this there are three district managers for Trincomalee, Batticaloa and Ampara to execute the program.
