3. Bid documents may be inspected free of charge on the submission of the documents mentioned above (a) and (b) of para 2.
4. Bids shall be valid for a period **120** days after the date bid opening.

All Bids (original & copies) should be completed according to the bidding condition, and shall be delivered to **Chairman, Procurement Committee, Provincial Department of Health Services, 120 Court Road, Trincomalee** on before **09.08.2016 at 3.00 pm.** “ *Bids for IFB Ref No* “ Should be clearly stated on the left hand top corner of the envelope and bids will be opened soon after closing in the presence of the bidders / representatives who choose to attend.
6. Late bids will be rejected.
7. All bids shall be accompanied by a Bid Security obtained from recognized commercial bank approved by the Central Bank of Sri Lanka valid up to **104** days from closing date of bids. The value of bid security should be 2% out of total bid price of item.
8. The chairman, of the Procurement Committee reserves himself the right of rejecting any or all tenders and the right of accepting any portion of the tender. The decision of the procurement committee regarding this tender will be final.
