INVITATION FOR BIDS

Health Infrastructure Development Programme in Eastern Province Provincial Department of Health Services

1. The Democratic Socialist Republic of Sri Lanka fund allocated through the office for National Units and Reconciliation Project to **Health Infrastructure Development Programme in Eastern Province** for the following civil works contract as described in the table below.
2. The Chairman Department Procurement Committee on behalf of the **Provincial Department of Health Services, Trincomalee** invites sealed bids from eligible and qualified bidders for the following works as described in the table below.
3. Bidding will be conducted through **National Competitive Bidding** Procedure.
4. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall have been registered in the field of Building construction for grade mentioned in the table below with the Institute for Construction Training and Development (ICTAD)
5. Qualifications requirements are indicated in section 4 of the Bidding document. Additional details are provided in the Schedule (Section5) of the bidding document.

A complete set of Bidding Documents in English language may be purchased by interested bidders on the submission of a written application to the **Chairman, Department Procurement Committee, Trincomalee** from **10.05.2017** until **30.05.2017** from **9.00 hrs to 15.00 hrs** upon payment of a non-refundable fee of **Rs 2000/=**.The method of payment should be by cash.
8. Bids shall be delivered to the **Chairman, Departmental Procurement Committee, Eastern Province, Trincomalee** on or before **14.30 hrs on 31.05.2017**. Late Bids will be rejected & Bids will be opened soon after closing in the presence of the Bidder's representatives who choose to attend.
9. Bid shall be valid for 77days (seventy seven) up to **25.07.2017** after the dead line for bid submission.
10. Bid shall be accompanied by a Bid security as per the information given in the Table.
