



# INVITATION FOR BIDS

2. The bidding will be conducted through **National Competitive Bidding**, However limited to the bidders who are registered within the **administrative boundary of the Eastern Province**.
3. Bidding documents may be purchased during office hours up to **03.00pm** on **24.10.2017** at the **respective offices of the Executive Engineer, Department of Buildings (as mentioned in table)** on submission of receipts for the proof of payment for Non-Refundable fee mentioned below, made at the office of the **respective offices of the Chief Engineer, Department of Building (as mentioned in table)**.
4. A Bidder is entitled to obtain the bidding documents in duplicate. Interested bidders may inspect the bidding documents free of charge, prior to collection, if desired and obtain further information from the **respective offices of the Executive Engineer, Department of Buildings (as mentioned in table)**.
5. Bid accompanied by a bid security for the amount mentioned below shall be reached to the **Chairman, Departmental Procurement Committee, Provincial Director's Office, Department of Buildings, Inner Harbour Road, Trincomalee on or before 02.30 pm on 25.10.2017**. Bids will be opened at **Provincial Director's Office, Department of Buildings, Inner Harbour Road, Trincomalee** soon after closing, in the presence of the bidders/ representatives who choose to attend. Late bids will be rejected.
6. A Pre bid meeting will be conducted on **17.10.2017** at **10.00 am** at the **respective offices of the chief Engineer's office, Department of Buildings (as mentioned in table)**.
7. Procurement committee's decision is the final in awarding contract.
