The Chairman, **Provincial Ministry Procurement Committee** on behalf of the **Ministry of Education, information Technology Education Pre School Education, Sports, Cultural Affairs, Youth Affairs, Rehabilitation & Resettlement, Eastern Province** now invites sealed bids from eligible and qualified bidders for **Construction of Three(03) Buildings** with the cost estimates as described below.

A complete set of Bidding Documents may be purchased by interested bidders on the submission of a written application to the above mentioned **respective** Zonal Education Office from **04.11.2016 until 21.11.2016 from 09.00 hrs to 15.00 hrs** on working days on production of the receipt issued by the Accountant of above mentioned **respective** Zonal Education Office upon payment of non-refundable fees **Rs. 3,500.00** for each bidding document. The method of payment will be by Cash.
 7. Bids must be delivered in duplicate to the address given below or deposited in the Tender Box kept at the **Provincial Ministry of Education, Eastern Province, Inner Harbour Road, Trincomalee** on or before **15.00 hours on 23rd of November 2016** **Late bids will be rejected.** Bids will be opened soon after closing in the presence of the bidder's representative who chooses to attend.
 8. Bids shall be valid up to **07.02.2017 (77 days)**.
 9. All bids shall be accompanied by a Bid Security from bank approved by the Central Bank of Sri Lanka or Construction Guarantee Fund (CGF) of amounts stated in the Table-1. Bid security should be valid up to **07.03.2017** from **23.11.2016**.
 10. Pre-bid meeting for all **Three** contracts will be held at the **Auditorium Provincial Ministry of Education, Eastern Province, Inner Harbour Road, Trincomalee** on **18.11.2016** at **10.30** am.
