1. The Chairman, **Department Procurement Committee (DPC)-Major** of Provincial Irrigation Department, Eastern Province invites sealed bids from eligible and qualified bidders for the civil works as described in the table below.

2. Bidding will be conducted through National Competitive Bidding, however, **limited to the bidders who registered within the administrative boundary of the Eastern Province.**
3. To be eligible for contract award, the successful bidder shall not have been blacklisted and shall meet the **CIDA** registration and qualification requirements listed above. Additional details and work experience required are provided in the Bidding Documents.
4. This contract work should be completed before the 28<sup>th</sup> of December-2017.

A Complete set of Bidding Documents in English language may be purchased by interested bidders on submission of a written application to the **Director of Irrigation, Yard Road, Batticaloa** whose addresses shown above from **10.11.2017 to 20.11.2017** from **09.00hrs to 15.00hrs** upon payment of a non-refundable fee of **Rs. 4000.00** for each set. The method of payment will be by **cash**.

Bids shall be delivered to the **Chairman, Department Procurement Committee (DPC)-Major, Provincial Irrigation Department, Yard Road, Batticaloa at or before 14.00hrs on 22.11.2017.** Late Bids will be rejected and the Bids will be opened immediately after the closing in the presence of the bidders/ representatives who choose to attend.

Bids and the Bid security shall be valid for a period of **77 days** and **91 days** respectively after the date of bid opening and the Bid shall be accompanied by a bid security **in the format** annexed to the Bidding Document and it shall be obtained from **recognized organizations** in Sri Lanka.
