To be eligible for contract award, the successful bidder shall not have been blacklisted or defaulted and shall be Eastern Province Regional Contractor (Registered address to be within Eastern Province) registered in the field of Building Construction for above mentioned grade or above with the Construction Industry Development Authority (CIDA).
3. Interested bidders may obtain further information and inspect the bidding documents at the **respective** office of Zonal Director of Education during office hours from 09.00 to 15.00 hours.
4. A complete set of Bidding Documents in English language may be purchased from the office of **respective** Zonal Director of Education by interested bidders on the submission of a written application **from 15.07.2016 until 28.07.2016 from 09.00 hrs to 15.00hrs**. Upon payment of a non refundable fee of LKR 1,000/= the method of payment will be in cash to the office of the **respective** Zonal Director of Education.
5. Bids shall be delivered to the office of the *Ministry of Education, Information Technology Education, Pre School Education, Sports, Cultural Affairs, Youth Affairs, Rehabilitation & Resettlement, Eastern Province, Trincomalee* **on or before 15.00 hours on 29.07.2016**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidders' representatives who choose to attend.
6. All bids shall be accompanied by a **Bid Security on the name of secretary, Ministry of Education, Eastern Province Trincomalee**. For rupees above mentioned which should be obtained from a reputed Bank operating in Sri Lanka or Construction Guarantee Fund (CGF) valid **for a period of 120 days (29.07.2016 to 25.11.2016)** from date of close of bids. The Bid Security should be "On-demand" & "Un-conditional" and on the format given in the Bidding Document.
7. Provincial Ministry of Education, Cultural Affairs, Land & Land Development and Transport. Will not be responsible for any costs or expenses incurred by bidders in Connection with the preparation or delivery of bids.
