To be eligible for contract award, the successful bidder shall not have been blacklisted or defaulted and shall be Eastern Province Regional Contractor (Registered address to be within Eastern Province) registered in the field of Building Construction for above mentioned grade with the Construction Industry Development Authority (CIDA).

A complete set of bidding documents in duplicate in English language may be purchased by interested bidders on the submission of a written application to the respective Zonal Education Office mentioned above **from 24.07.2017 until 11.08.2017 from 09.00 hrs to 15.00 hrs** hours upon payment of non-refundable fee of **Rs. 5,000.00**. The method of payment will be by cash at Accounts Branch of Zonal Education Office.

06. Bids shall be valid up to 90 Days after the deadline for Bid submission.

07. All bids shall be accompanied by bid security from either a reputed Bank approved by Central Bank of Sri Lanka or Construction Guarantee Fund (CGF). Bid Security should be valid up to **108 days** from **14.08.2017**.

08. Pre-bid meeting for all bids will be held at the **Auditorium Provincial Ministry of Education, Eastern Province, Inner Harbour Road, Trincomalee** on **10.08.2017** at **10.30am**.

09. Bids must be delivered in duplicate to the address below **Ministry of Education, Eastern Province, Inner Harbour Road, Trincomalee** on or before 15.00 hours on **14.08.2017**. Late bids will be rejected. Bids will be opened soon after closing in the presence of the bidder's representative who chooses to attend.
