Bidding documents may be purchased during office hours up to **03.00pm** on **23.03.2017** at the office of the **Executive Engineer, Department of Buildings, Kalmunai** on submission of receipts for the proof of payment for Non-Refundable fee mentioned below, made at the office of the **Chief Engineer, Department of Buildings, Kalmunai**.
4. Procurement method will be **National Competitive Bidding**, Single stage Single envelop system.
5. A Bidder is entitled to obtain the bidding documents in duplicate. Interested bidders may inspect the bidding documents free of charge, prior to collection, if desired and obtain further information from the **Executive Engineer, Department of Buildings, Kalmunai (Telephone Number: 067-2229153)**

Bid accompanied by a bid security for the amount mentioned below shall be reached to the **Chairman, Departmental Procurement Committee, Provincial Director's Office, Department of Buildings, Inner Harbour Road, Trincomalee** on or before **02.30 pm** on **24.03.2017**. Bids will be opened at **Provincial Director's Office, Department of Buildings, Inner Harbour Road, Trincomalee** soon after closing, in the presence of the bidders/ representatives who choose to attend. Late bids will be rejected.
7. A Pre bid meeting will be conducted on **15.03.2017** at **10.00 am** at the chief Engineer's office, Department of Buildings, Kalmunai.
