Eastern Provincial Road Passenger Transport Authority (Amendment) Statute No. 01 of 2014

A statute to amend the Eastern Provincial Road Passenger Transport Authority Statute No. 02 of 2009.

Be it enacted by the Eastern Provincial Council of the Democratic Socialist Republic of Sri Lanka as follows ;

| Short title and date of operation | 01. This Statute may be cited as “the Eastern Provincial Road Passenger Transport Authority (Amendment) Statute No. 01 of 2014” and shall come into effect from the date on which the assent of the Governor of the Eastern Province is sought. |
| Amendment to Section 36 of the Principle Statute | 02. Section 36 Sub section (2) and paragraph (a) of the Eastern Provincial Road Passenger Transport Authority Statute No. 02 of 2009 (hereinafter referred to as the Principle Statute) are hereby amended as follows ;

“(2) The following receipts of the Authority shall first and foremost be credited to the Provincial Fund and thereafter paid to the Account based on the necessity of the Authority.

(a) Issuing or renewing the permits by the Authority in the event of exercising and performing its power and duties and the receipts thereof” |
| Tamil text to prevail in case of inconsistency | 03. In the event of any inconsistency between the Tamil and Sinhala texts of this Statute, the Tamil text shall prevail |
